



海洋公園(本園) 探索號 R 工作坊 小小隱身專家/大自然忍者 條款及細則

(A) 參加者資格及條件

- 1. 小小隱身專家適合 2 至 3 小童參加; 大自然忍者適合 4 至 5 歲小童參加。參加者須與其家長/監護人陪 同參與。
- 2. 参加者如在活動前 24 小時內患有以下疾病,包括但不限於發燒、咳嗽、傷風/感冒、作嘔、腹瀉、嘔吐、皮疹、皮膚病、心臟病、肺病、血友病、腦癇症、對動物有恐懼,本園並不建議參與本活動。
- 3. 如參加者於活動前十四天內有與 2019 冠狀病毒病確診個案或疑似確診個案接觸·本園並不建議參與本活動。請盡早與本園聯絡,以便作出安排。
- 4. 参加者若感染預防及控制疾病條例(香港法例第 599 章)第一附表中載明之任何傳染病註 1·均不能參與本活動。
- 5. 參加者若身體不適,請留在家中休息,以保障所有參加者之安全。如有需要,本園亦會要求身體不適的 參加者於活動進行期間離開。
- 6. 參加者若作出對他本人或其他參加者構成危險或不安的行為,或不遵從本園導師發出的指引,本園會與 其家長溝通並以合適的方法處理該參加者的行為問題。但若情況未見改善,本園會在適當情況下請家長 帶參加者離開。本園不會對任何因行為問題而離開的參加者作出任何賠償。
- 7. 参加者入場須遵守海洋公園入口處所示之公園所有的附例及安全規則。海洋公園對公園內任何人士之任何財物的任何種類之損失或任何損害概不承擔任何責任或負責。
- 8. 參加者必須能夠在遇上緊急事故時,於本園職員的指示下迅速離開活動場地。
- 9. 任何情況下,參加者均須絕對遵從海洋公園員工之指示。
- 10.如參加者在活動期間遺失或損毀本園財產,參加者須照價賠償。
- **11.**本園職員擁有最終權力決定任何參加者是否適合參與活動·並為確保安全或秩序之情況下·有權拒絕任何人十參與活動。
- 12. 本園有權更改以上之參加者資格及條件,並無需另外通知。
 - 註 1: 該傳染病包括急性脊髓灰質炎(小兒麻痺)、阿米巴痢疾、炭疽、桿菌痢疾、肉毒中毒、水痘、基孔肯雅熱、霍亂、社區型耐甲氧西林金 黃葡萄球菌感染、2019 冠狀病毒病、克雅二氏症、登革熱、白喉、腸病毒 71 型感染、食物中毒、乙型流感嗜血桿菌感染(侵入性)、 漢坦病毒感染、侵入性肺炎球菌病、日本腦炎、退伍軍人病、麻瘋、鈎端螺旋體病、李斯特菌病、瘧疾、麻疹、腦膜炎雙球菌感染(侵入 性)、中東呼吸綜合症、流行性腮腺炎、新型甲型流行性感冒、副傷寒、鼠疫、鸚鵡熱、寇熱、狂犬病、回歸熱、風疹(德國麻疹)及先 天性風疹綜合症、猩紅熱、嚴重急性呼吸系統綜合症、產志賀毒素大腸桿菌感染、天花、豬鏈球菌感染、破傷風、結核病、傷寒、斑疹傷 寒及其他立克次體病、病毒性出血熱、病毒性肝炎、西尼羅河病毒感染、百日咳、黃熱病和寨卡病毒感染。





(B) 基本條款

- 1. 每份報名表只供一位參加者及一名陪同家長報名一個活動。
- 2. 所有報名表必須由參加者之家長或家長授權的監護人(需年滿 18 歲或以上)清楚填寫。
- 3. 所有已繳交之參加費用恕不退還。
- 4. 除(E)部及(F)部所列明之條款以外,報名一經確定,參加者不得轉換活動班別、日期、時間或參加者姓名。
- 5. 小小隱身專家 (2-3 歲)、大自然忍者 (4-5 歲)的參加者須有一位家長或家長授權的監護人陪同。活動費用包括 1 位成人及 1 位小童參與六十分鐘的教育活動。
- 6. 參加者與陪同的家長或監護人必須於活動期間穿著襪子。
- 7. 参加者必須準時於指定地點集合,逾時不候。
- 8. 工作人員將於活動當日以參加者之姓名及電郵確定信核對。
- 9. 除得到本園導師批准外,所有參加者不得擅自離開團隊。
- **10**. 請勿攜帶貴重物品參與本活動,海洋公園對園內任何人士之任何種類之損失或任何損害概不承擔任何 責任或負責。
- 11. 本活動之費用並不包括入場門票·參加者及其陪同家長或家長授權的監護人必須持有活動當日有效之海洋公園入場門票。
- 12. 活動費用並不包括探索號 R 門券。如欲於活動後繼續體驗探索號 R, 必須自費購買探索號 R 門券。
- 13. 本活動不接受任何隨行訪客(包括3歲以下小童)。

(C) 報名方法及程序

報名必須於活動日最少 3 日前於網上遞交。活動名額先到先得,額滿即止。報名成功完成後會即時收 到電郵確定信,請留意確定信有否被誤標示為垃圾郵件。

(D) 付款方法

- 1. 報名只接受以 Visa 及萬事達信用卡付款。本園將從報名時使用的信用卡戶口內扣除有關之活動費用。 所有已繳交之費用恕不退還。
- 2. 每張信用卡每天接受最多 3 次交易。
- 3. 為了令網上購票更為安全,我們備有 Visa 驗證服務和 MasterCard®SecureCode™服務。請於報名前確保所使用的信用卡已透過發卡機構的登記網頁啟動驗證服務。
- 4. 為了提供最佳網路體驗,請避免使用 Internet Explorer 瀏覽器購票。





(E) 活動更改或取消

- 1. 本園擁有最終決定權即時終止或取消活動。
- 2. 若報名人數不足,本園有權取消或更改活動日期。
- 3. 如探索號 R 於活動日因任何情況關閉或暫停開放引致本園提出取消活動,本園會安排改期。

Ocean Park (The Park) Explorer R Workshop Camouflage Kids / Ninja in Nature Terms and Conditions

(A) Criteria for Participation

- 1. "Camouflage Kids!" is suitable for children aged 2 to 3; "Ninja in Nature" is suitable for children aged 4 to 5.
- 2. Participants suffering from any disease within a previous 24-hour time frame (including, but not limited to fever, cough, cold/flu, nausea, diarrhea, vomiting, rash, skin disease, heart disease, lung disease, haemophilia, epilepsy, phobia of animals,) are not recommended to participate in this programme.
- 3. If a participant is in touch with a suspected or confirmed case of COVID-19, it is not recommended to participate in this programme. Please contact us as soon as possible to make appropriate arrangement.
- 4. Participants suffering from any infectious disease specified in the First Schedule to the Prevention and Control of Disease Ordinance (Cap 599 of the laws of Hong Kong) Remark 1 will not be allowed to take part in this programme.
- 5. To safeguard all participants, sick participants will be requested to stay home. Ocean Park reserves the right to request sick participants to leave the programme in case of such necessities.
- 6. If a situation arises where a participant threatens the safety or security of other participants, or if a participant shows disregard of programme guidelines, we will make every appropriate effort to communicate with the parents to handle the participant's behaviour. Should the disruptive behaviour continue, the participant may be dismissed from the programme and should leave the Park with his/her parents at the discretion of Ocean Park. The Park will not be held responsible for any cost associated with a child's dismissal on the ground of disruptive behaviour.
- 7. A condition of entry is to comply with all the park's By-laws and safety rules which are available at the entrance of Ocean Park. Ocean Park shall be under no liability or responsibility for any loss of any kind or any damage to any property of any person in the Park.
- 8. In case of emergency, participants must be able to quickly exit the activity venue under the guidance of Park's staff.
- 9. Participants must absolutely follow all the instructions given by the Park's staff at all times.
- 10. If the Park's property is found lost or damaged during the programme, reimbursement in full cost must be made by the participant concerned.
- 11. The Park's staff shall at all times have the full and final right to determine whether any participant is suitable for the programme and may refuse entry if refusal is necessary to ensure safety or order.
- 12. The criteria listed above are subject to change at the discretion of the Park and without prior notice.

Remark 1: These diseases include Acute poliomyelitis, Amoebic dysentery, Anthrax, Bacillary dysentery, Botulism, Chickenpox, Chikungunya fever, Cholera, Community-associated methicillin-resistant Staphylococcus aureus infection, Coronavirus disease 2019 (COVID-19), Creutzfeldt-Jakob disease, Dengue fever, Diphtheria, Enterovirus 71 infection, Food poisoning, Haemophilus influenzae type b infection (invasive), Hantavirus infection, Invasive pneumococcal disease, Japanese encephalitis, Legionnaires' disease, Leprosy, Leptospirosis, Listeriosis, Malaria, Measles, Meningococcal infection (invasive), Middle East Respiratory Syndrome, Mumps, Novel influenza A infection, Paratyphoid fever, Plague, Psittacosis, Q fever, Rabies, Relapsing fever, Rubella and congenital rubella syndrome, Scarlet fever, Severe Acute Respiratory Syndrome, Shiga toxin-producing Escherichia coli infection, Smallpox, Streptococcus suis infection, Tetanus, Tuberculosis, Typhoid fever, Typhus and other rickettsial diseases, Viral haemorrhagic fever, Viral hepatitis, West Nile Virus Infection, Whooping cough, Yellow fever and Zika Virus Infection.





(B) General Conditions

- 1. One enrolment is for one participant and one programme only.
- 2. All enrolment documents should be clearly filled in by the parent or the authorized guardian (aged 18 or above).
- 3. All payments made are non-refundable.
- 4. The chosen programme code, date, time and participant's name cannot be changed upon confirmation, except the circumstances stated in Part (E) and Part (F).
- 5. Participants of Camouflage Kids! (2-3 years old) and Ninja in Nature (4-5 years old), must be accompanied by their parents or authorized guardians throughout the programme. The programme fees include a 60-minute educational programme for 1 accompanying caregiver and 1 child (including walking time between different locations).
- 6. Participants and their parents or guardians must wear socks during the programme.
- 7. Please arrive at the gathering point punctually. Late-comer might not be admitted to the programme.
- 8. Participant's name and the email of confirmation letter should be presented for verification on the programme date.
- 9. All participants are not allowed to leave the group without prior approval from the instructor.
- 10. It is highly recommended that no valuable items should be brought to the Park. Ocean Park shall be under no liability or responsibility for any loss or any damage to the property of any participant in the Park.
- 11. Valid admission tickets for both accompanying caregiver and participant to the Park are required to join the programme. The price of the admission ticket is not included in the programme fee.
- 12. The programme fee does not include Explorer R ticket. Participants who wish to continue exploring the "Explorer R" after the class must purchase the Explorer R ticket separately.
- 13. No additional accompanying guest is allowed (including child under the age of 3) in the Explorer R.

(C) Enrolment Method & Procedures

Enrolment must be made online at least 3 days before the first day of programme. Enrolment will be considered on a first-come-first-serve basis. A confirmation letter will be sent via email once the payment has been received. Please also pay attention if the confirmation letter was wrongly identified as spam or junk mail.

(D) Payment Method

- 1. Payment should be made by credit card (Visa and Master) only. The programme fee will be debited from the credit card account provided in the online enrolment. All payments are non-refundable.
- 2. A maximum of 3 transactions can be made per credit card per day.
- 3. For your protection, Verified by Visa and MasterCard®SecureCode™ is available in our payment gateway. Please ensure that the credit card for payment has been duly activated for verification service through its card issuer before your enrolment.
- 4. For better website experience, please avoid using Internet Explorer browser for the enrolment.





(E) Cancellation and Changes of Programme

- 1. Decision for immediate cancellation of the programme shall be at the sole discretion of Ocean Park.
- 2. If there is insufficient enrolment, we reserve the right to cancel or arrange another programme date for the participant.
- 3. If the Explorer R is closed or temporarily suspended on the programme day, which lead to class suspension initiated by the Park, make-up class / reschedule to other existing classes would be arranged for participants to choose.
- 4. The itinerary or content of the programme may be subject to change without prior notice.
- 5. Programme will be cancelled under the following circumstances. Ocean Park will not contact parents for adverse weather arrangement on the programme date before the camp starts under normal circumstances, please check the below details:
 - i. A red or black rainstorm warning is issued by the Hong Kong Observatory;
 - ii. A Tropical Cyclone Warning Signal No. 3 or above is hoisted by the Hong Kong Observatory;

- 2. Subject to the presentation of a doctor's certificate, a partial refund of impacted day(s) will be arranged after deducting an administration fee of HK\$100.
- 3. An administration fee of HK\$100 will be charged to each sick leave (with doctor's certificate), course change or refund request. Applicants must fill in the refund/ reschedule application form and return to the Park for processing.
- (G) Ocean Park reserves the right to change the above contents at any time without further notice.
- (H) In case of any dispute, the decision of Ocean Park Corporation shall be final and binding.
